## Firmware Release and new NOR for 16GB NVDIMM-N

**Revision History:**

04/20/2018 — PCN 32536 is being canceled, due to a change in availability of the NOR device discussed in this PCN. Although the NOR is EOL, there is adequate supply for the foreseeable future. FW version 2.4 discussed in this PCN will still be introduced into the product in PCN#32735, due to be released in early May 2018.

NOR device on NVDIMM is being replaced with equivalent. The current NOR device, N25Q064A13EF640FN04 is EOL as described in PCN 32435. It is being replaced with MT25QL128ABA1EW7-0M03IT.

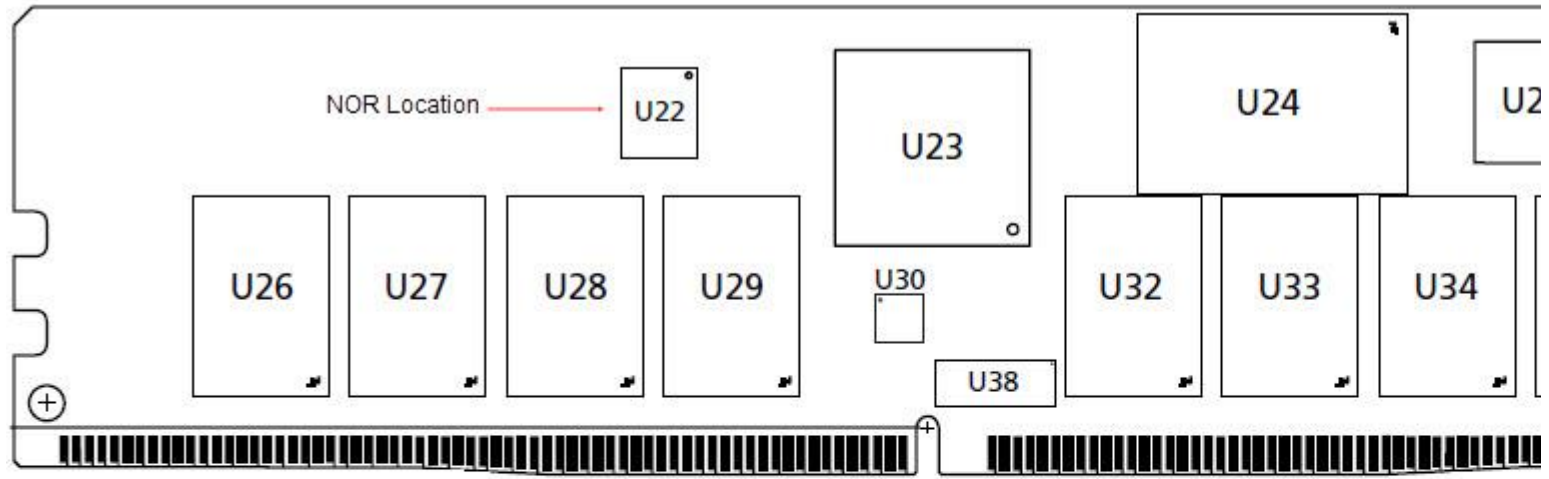
