Description for Product Discontinuation

The legacy style split grommet sleeves and the cable feed-through adapter blocks (for use with HEAVYCON bases) are being discontinued. The current CES (Cable Entry System) products stand as the replacement system for these products.

The current CES system, while it shares mounting dimensions with HEAVYCON bases, is not directly interchangeable with individual legacy split grommet sleeves and cable feed-through adapters. CES does however allow for a greater density of cables to pass through the same space. The old system in the B24 size allowed for a max of four cables while CES can carry up to forty cables.
