We will discontinue the sale of the current products as shown below. Please place orders for substitute products.

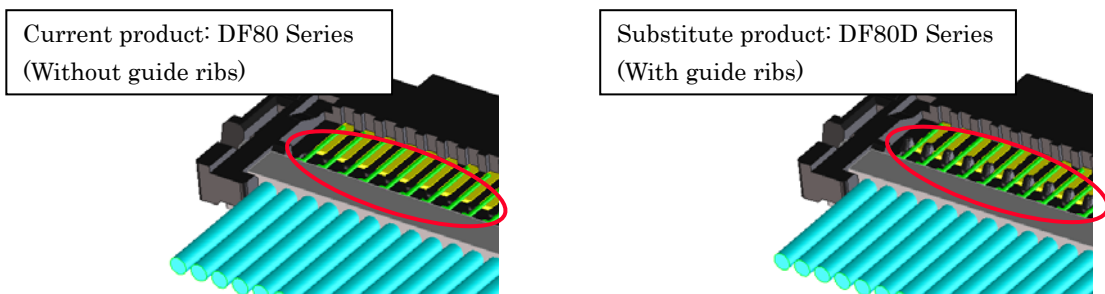
