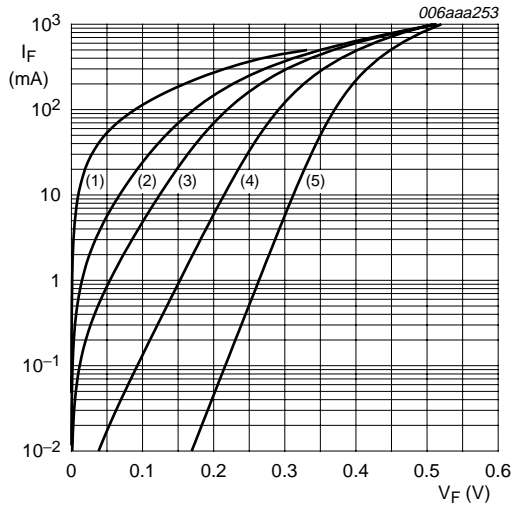

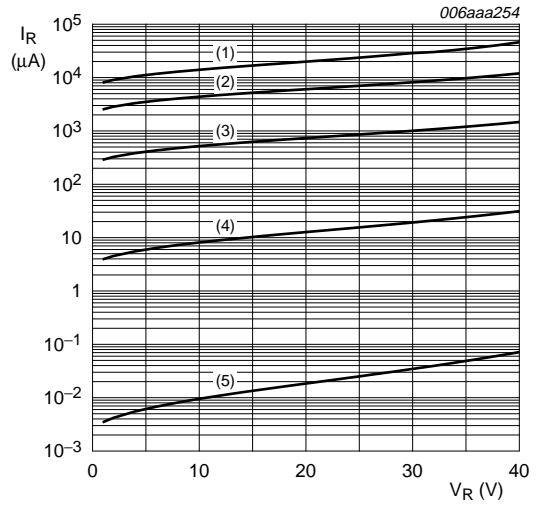

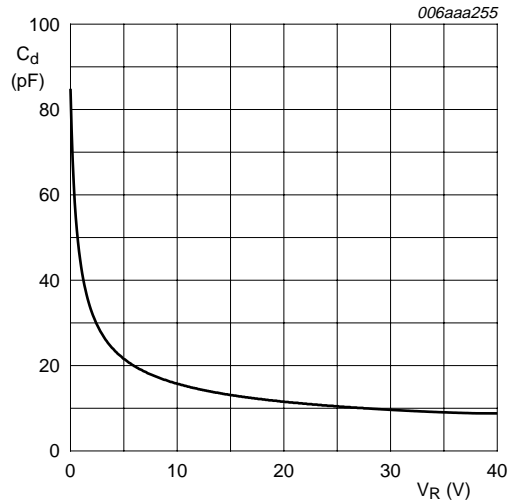

- (5) $T_{amb} = -40\text{ °C}$

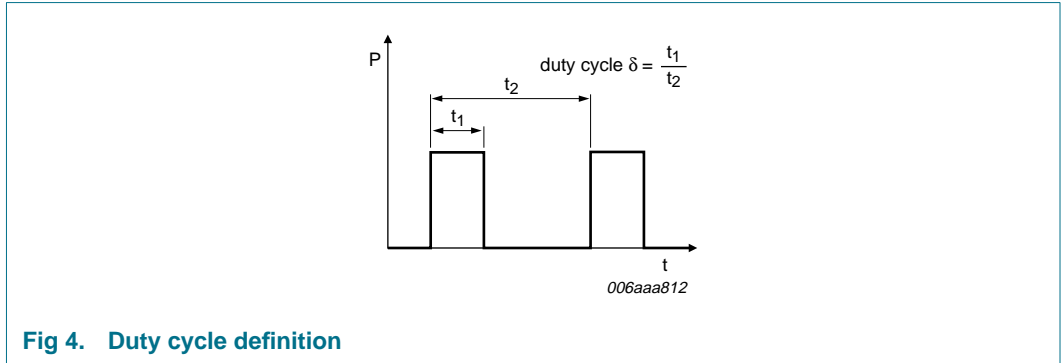
Fig 2. Reverse current as a function of reverse voltage; typical values



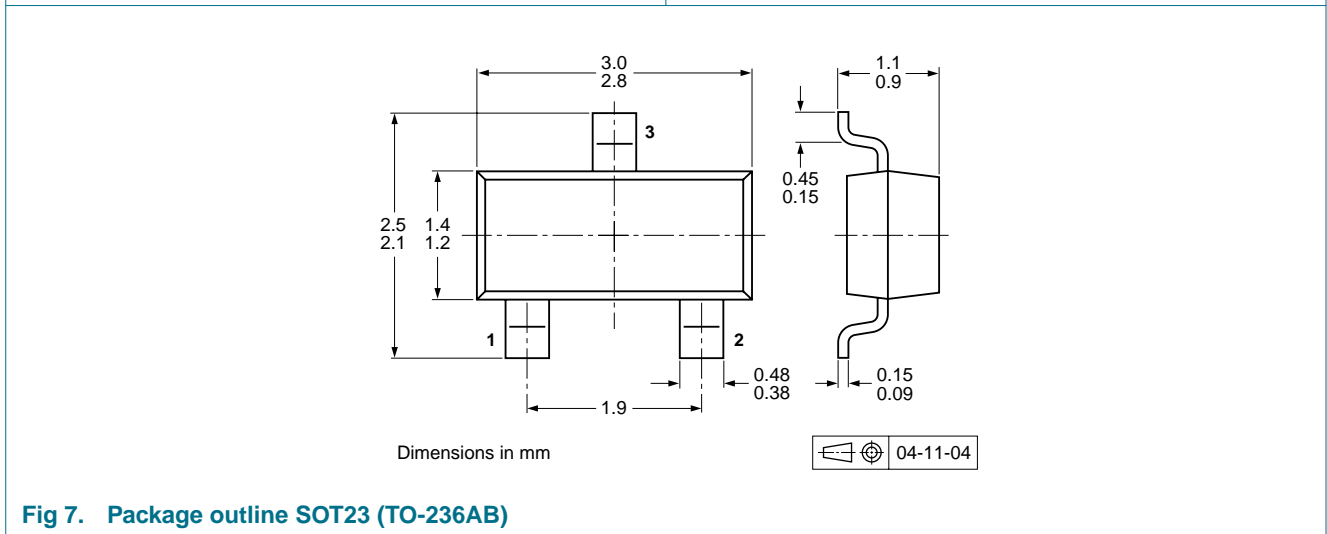
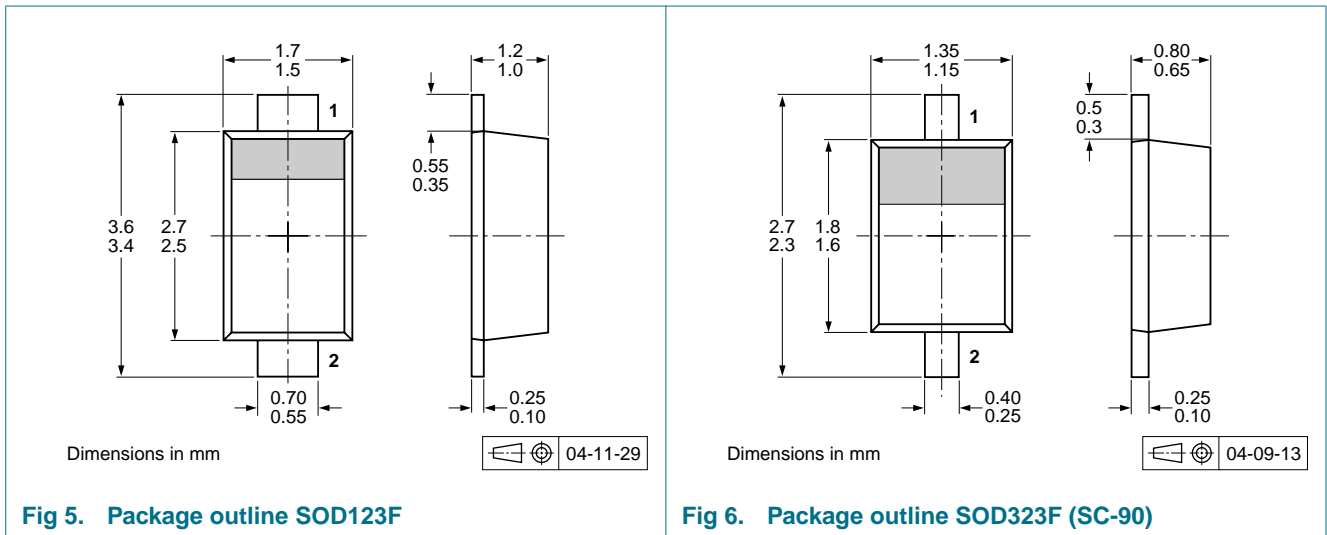
$f = 1\text{ MHz}; T_{amb} = 25\text{ °C}$

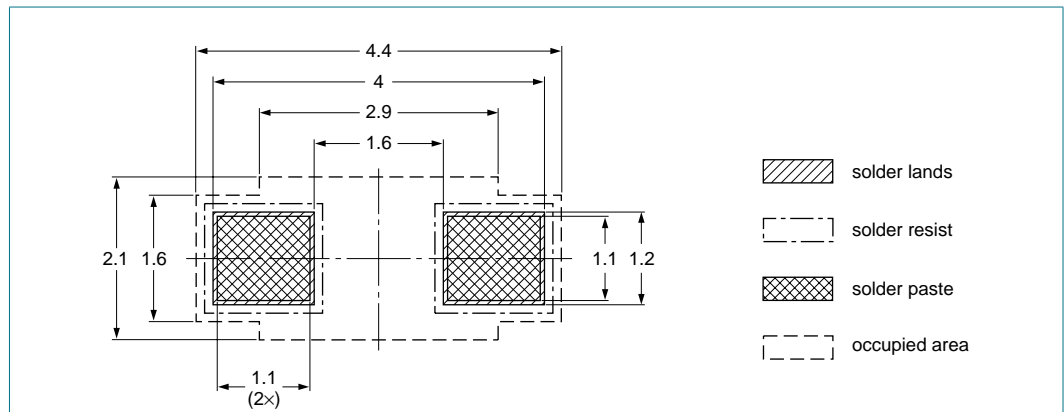

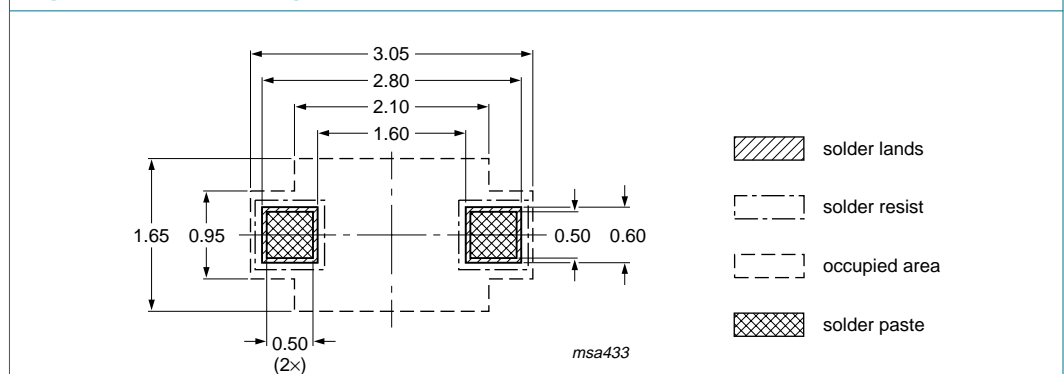

Fig 9. Reflow soldering footprint SOD323F (SC-90)

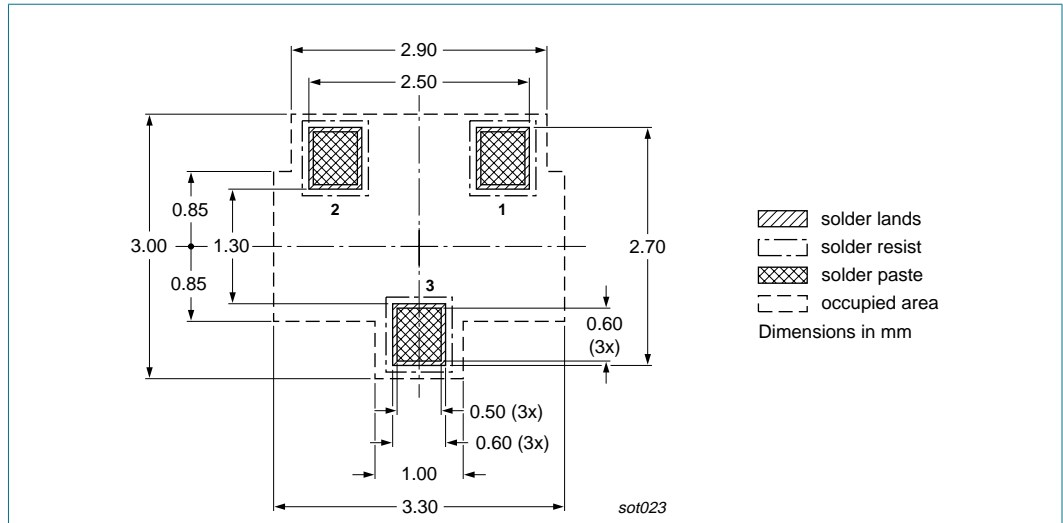


Fig 10. Reflow soldering footprint SOT23 (TO-236AB)

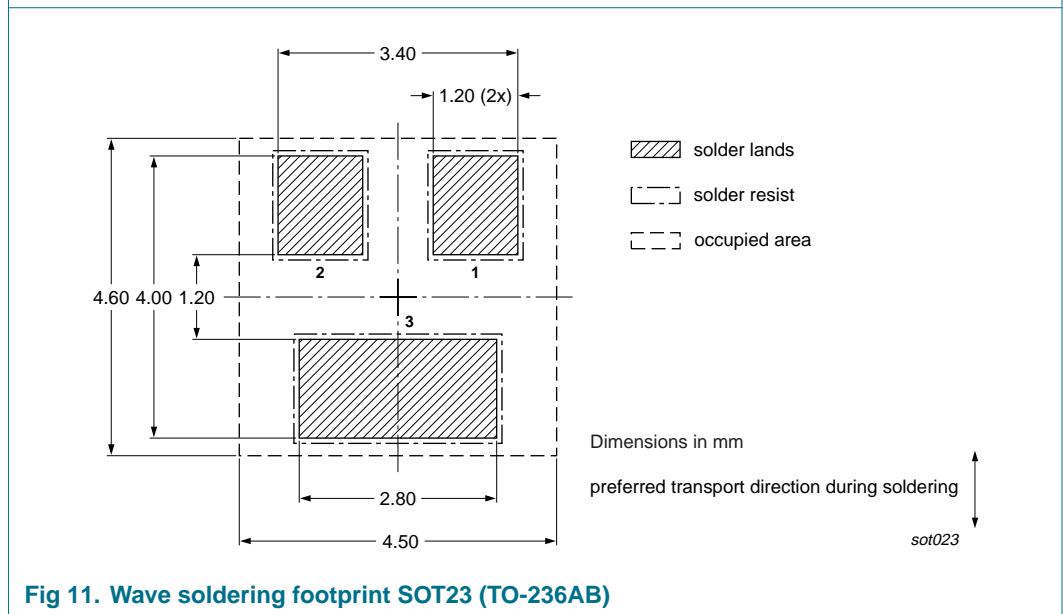


Fig 11. Wave soldering footprint SOT23 (TO-236AB)
