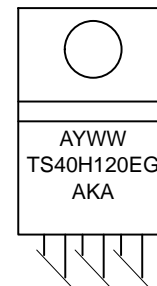

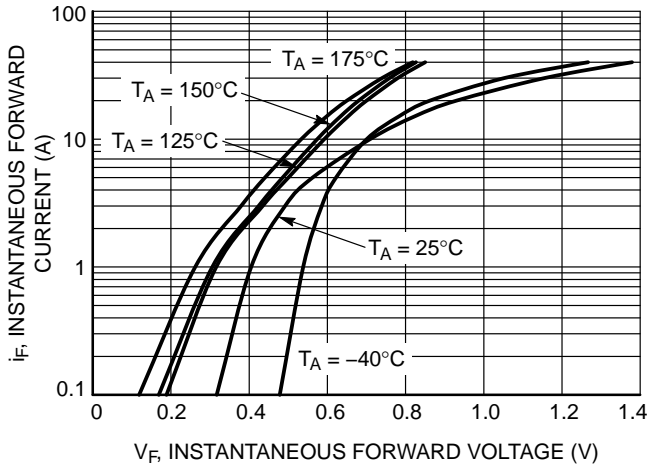

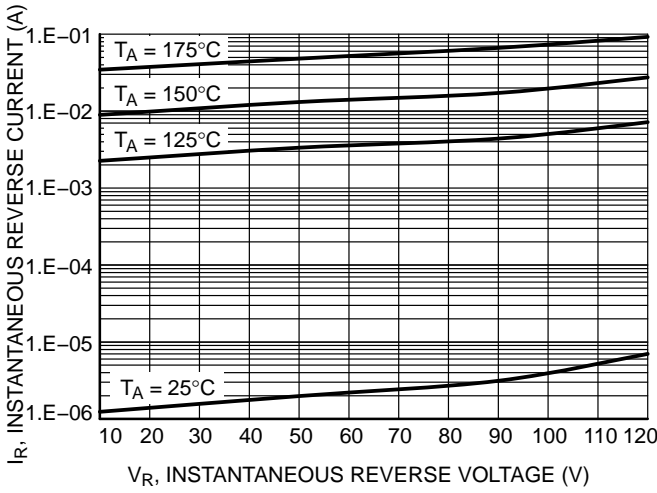

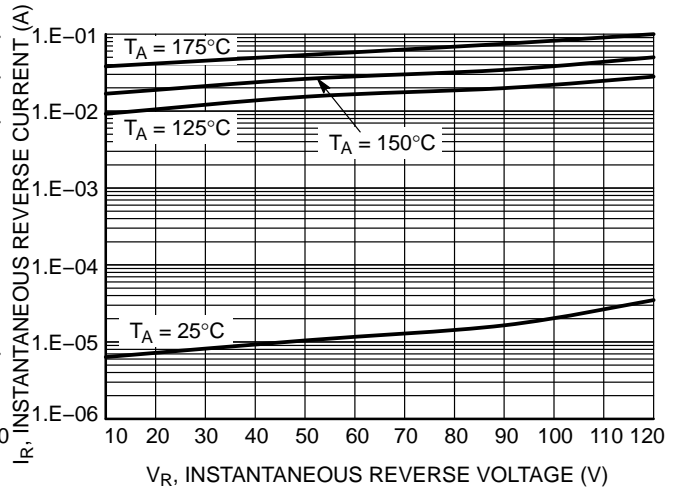
**Figure 1. Typical Instantaneous Forward Characteristics**



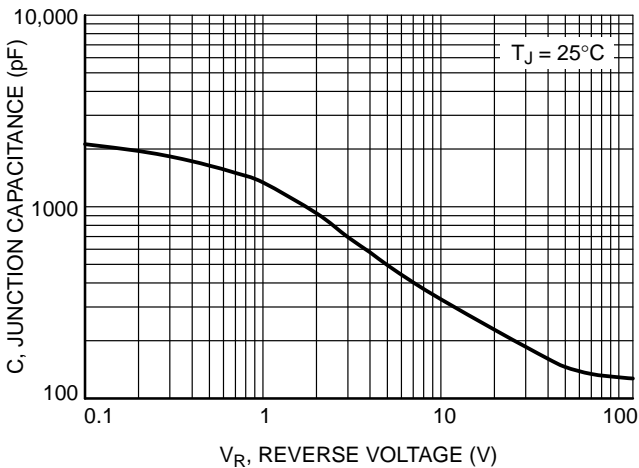
**Figure 2. Maximum Instantaneous Forward Characteristics**



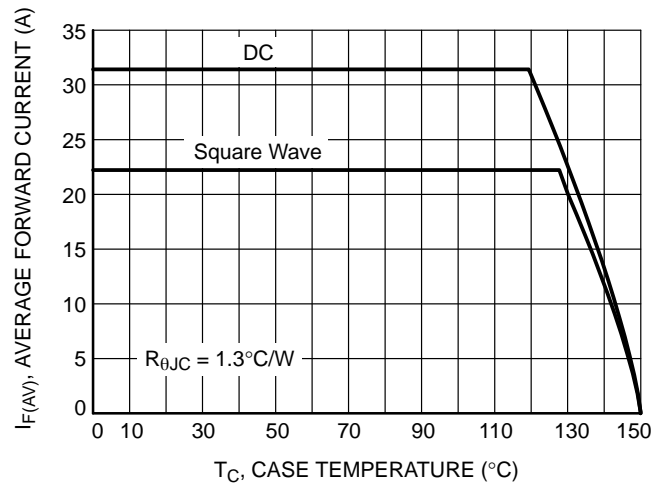
**Figure 3. Typical Reverse Characteristics**

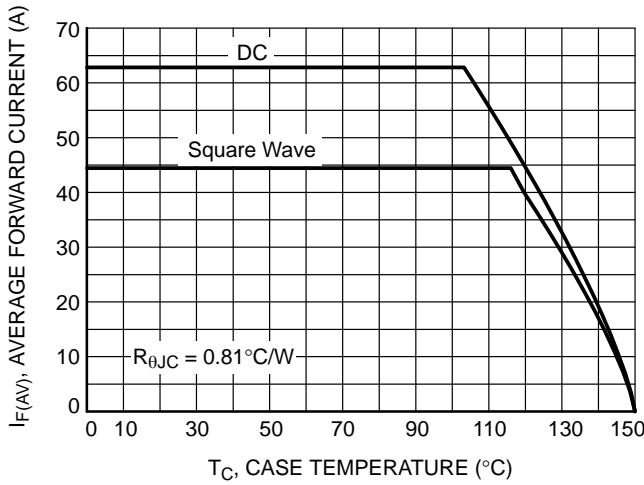


Figure 7. Current Derating per Device

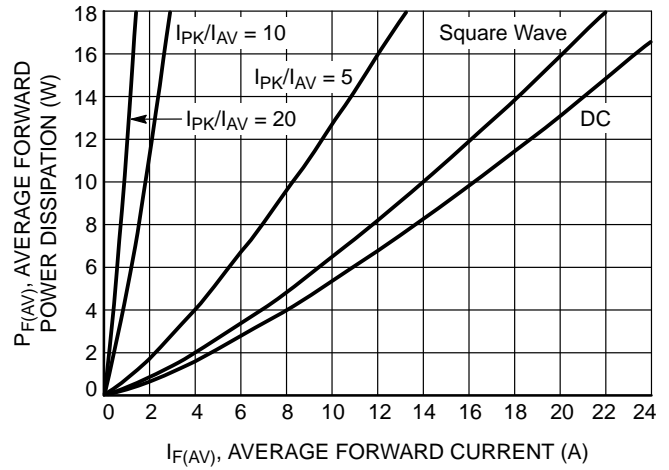


Figure 8. Forward Power Dissipation

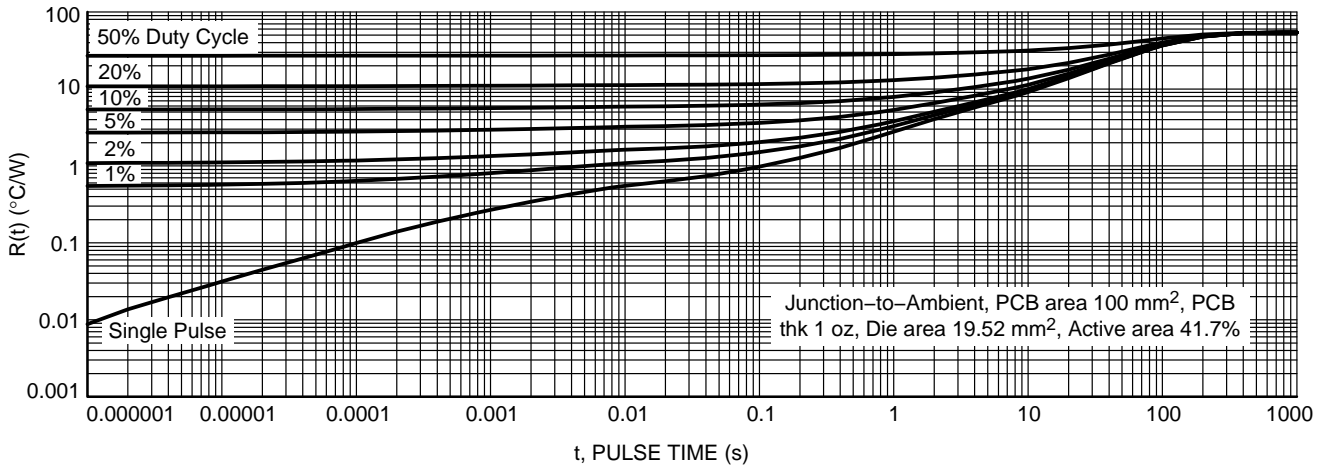


Figure 9. Thermal Characteristics
